PUBLIC BENEFIT REPORT FOR 2010 OF CENTRAL EUROPEAN SERVICE FOR CROSS-BORDER INITIATIVES

Central European Service for Cross-Border Initiatives (CESCI) was established in 2009 by the restructuring of the National Professional Association for European Union Grants and Contributions founded in 2004. Key goals of CESCI include:

- providing professional support for cross-border co-operation along Hungary's borders and in other countries of Central and South-East Europe
- establishing the network of Euroregions, EGTCs, local and regional authorities involved in cross-border co-operation
- promoting the adoption of best practices from Western Europe
- establishing strategic co-operation with competent decision making and decision preparing institutions of the European Union as well as with Northern and Western European networks created for the same purpose
- improving internal cohesion and mutual agreement within Central and Eastern Europe by establishing partnerships between these countries.

CESCI's membership is composed of natural and legal persons that are involved in cross-border cooperation, agree to comply with CESCI's operational regulations and fulfill their obligations as members.

In December 2010, CESCI's membership included 15 natural persons and 21 legal persons.

1. Financial report

CESCI's total not-for-profit revenue in 2010 was HUF 17 188 000 that exceeded its 2009 revenue by nearly HUF 15 million.

Membership fees totalled HUF 731 000 while public benefit activities generated HUF 13 286 000. Our four winning bids earned us funding worth HUF 6 392 000 out of which HUF 3 127 751 was spent in 2010.

Other revenue: HUF 43 000 generated from rounding of amounts on the National Tax and Customs Office account and interest earned on bank accounts.

Expenses of public benefit activity totalled HUF 25 928 000 dominated by personnel expenses amounting to HUF 17 868 000. Material expenses were also high (HUF 7 463 000) mostly including purchases for various CESCI events.

CESCI awarded HUF 100 000 to the third place finisher of the First Pálfi István Tender.

Yearly public benefit earnings: HUF - 8 739 000.

2. Statement on the use of budgetary allocations

CESCI did not receive any earmarked budgetary allocation in 2010.

4. Earmarked allocations

In 2010, CESCI allocated an award worth HUF 100 000 to Lóránd Bali, third place finisher of Pálfi István Tender.

5. Statement on financial support received from central funds and local governments

In 2010, CESCI submitted four successful tenders responding to several calls.

We received HUF 1 400 000 from a Szülőföld Alap tender to organize the third Carpathian Basin Regional Development Workshop. Accounting documents for the total amount approved for the workshop held between April 16 and 18 2010 in Kishegyes, Serbia were submitted to the tender owner.

We received an operating grant worth HUF 500 000 from the Advisory Board for National Non-governmental Organizations under the National Civil Fund programme. The amount was spent on personnel expenses and costs of voluntary work.

We received a grant of HUF 2 995 000 from the International Civil Relations and European Integration Advisory Board under the National Civil Fund programme to organize an international professional conference related to Hungary's EU presidency. The conference discussing cross-border co-operation issues was held in Budapest between December 9 and 10 2010. Part of the grant

was paid only in 2011 and our publication presenting Budapest Platform established during the conference will be completed until the closing date (May 31 2011).

We received a grant of HUF 1 497 000 from the International Civil Relations and European Integration Advisory Board under the National Civil Fund programme to organize the second Mezőség civil workshop that was held in the spring of 2011.

6. Statement on payments made to CESCI's senior officials

No payments were made to CESCI's senior officials in 2010.

7. Professional report on CESCI's activities in 2010

The professional plan approved for 2010 defined the following objectives:

- > establishment of professional service: final office location, development of required professional team, collaboration with universities;
- > CESCI's international expansion: inclusion of foreign members in the Governing Board;
- > expansion of CESCI's membership: inclusion of legal persons from other countries;
- > organization diplomacy: establishing relations with foreign and EU professional and decision making organizations;
- > organization marketing: individual image, products and media campaign.

The following activities were completed in 2010.

CESCI's central office was relocated to an office building in Teréz avenue occupied by the Hungarian Academy of Sciences. We set our base here where the staff was gradually expanded. At the beginning of 2010, our secretary was CESCI's single employee. The staff was expanded by a lawyer at the end of January, a geographer and an economist in March and a sociologist in June. We continously recruited university students who completed their internship working for us. We concluded an agreement with Pázmány Péter Catholic University and started to prepare similar agreements with Szent István University, the Natural Sciences Faculty of ELTE and Corvinus University to employ their students. In the last qurter of 2010, we had a Polish visiting student working for us. Our newsletter in Hungarian and English has been published monthly since December.

CESCI significantly expanded its professional activity last year to be described in the report below.

a) Completed strategic documents

Review of EGTC regulation

Based on experiences from the Brussels meeting on July 13 organized by the Committee of the Regions, we drew up a comprehensive, analytic study including our proposals regarding the regulation.

New Széchenyi Plan debate document

We joined the professional debate on the chapters of the New Széchenyi Plan related to developments along Hungary's borders. Our document focused on development opportunities in EGTCs.

Cross-border co-operation strategy for Komárom-Esztergom county

The regional development county council commissioned CESCI to develop a cross-border co-operation strategy. A booklet describing the strategy has been published in Hungarian, Slovakian and English.

Government strategy regarding EGTCs

The Ministry of Public Administration and Justice commissioned CESCI to develop a three-volume document whose first volume discusses strategic issues connected to the establishment of EGTCs, the second volume describes the legal environment while the third volume is a handbook that could give guidance for the establishment of EGTCs. In addition to this 400-page document, the EGTC working group proposed to prepare a short summary supporting government measures.

European Danube Strategy

EDRS's Hungarian projects includes a project aiming to share Hungarian expertise and experience related to EGTCs in the Danube valley (this project has been developed and is planned to be managed by CESCI).

In addition to the above documents, CESCI was also involved in the development of the government's EGTC concept (the document was compiled by the staff of the Ministry of Public Administration and Justice).

b) Institutional development

CETC EGTC (Szczecin, Poland)

The consortium members of the Central European Transport Corridor (CETC) decided to establish an EGTC at their meeting on May 25. CESCI was commissioned to complete all professional tasks related to the establishment. The professional document preparing strategic decisions, the convention and statutes of the planned EGTC have been completed while the approval procedures in each member state and registration according to official seat will be conducted in 2011.

Danube Magistrale EGTC (Budapest)

The city of Ulm proposed to establish an EGTC related to the European Danube Strategy involving major cities along the Danube. Commissioned by the local government of Budapest, the EGTC's planned seat, CESCI has developed an analysis on preparations for the establishment of the EGTC.

Pons Danubii EGTC (Komárno)

The establishment process of the Komarno-based EGTC was co-ordinated by CESCI. The legal registration of this EGTC involving three Hungarian and three Slovakian towns was finalized by the competent Slovakian authority on December 16 2010.

Arrabona EGTC (Győr)

The planned EGTC will be initially founded by four cities (Győr, Mosonmagyaróvár, Dunajska Streda and Somorja) later to be joined by smaller local governments. The convention and the statutes have been approved by the involved local government bodies. The approval procedure began in November. The establishment process is being managed by CESCI staff.

RDV EGTC (Tatabánya)

Representatives from three counties (Komárom-Esztergom, Győr-Moson-Sopron and Nitra) discussed the establishment, organizational structure, registered seat and financing of a planned EGTC at the end of last August. Further negotiations will be held in 2011. Trnava county is also expected to join the co-operation.

c) Project development

High speed rail in South-East Europe

Proposed by CESCI and strongly supported by the State Secretariat for Foreign Economic Affairs of the Ministry for National Economy, a project is being developed to improve the high speed railway network within South-East Europe. CESCI has started professional preparations for the tender to be submitted under the INTERREG IVB programme collaborating with the Institute for Transport Sciences. CESCI also contributes to the work of the professional working group set up by the ministry.

Port construction in L\u00e4batlan and Kravany nad Dunajom (Karva, Slovakia)

CESCI compiled the second round project documentation for the project that was successful and has already been started.

d) Professional events

Carpathian Basin Regional Development Workshop

The third workshop for Hungarian professionals involved in Carpathian Basin regional development was held in Mali Idoš, Serbia to discuss cross-border co-operation. The workshop decided to strengthen the collaboration. The event was held between April 16 and 18 sponsored by Szülőföld Alap.

Pálfi István Memorial Day

The first Pálfi István Memorial Day was organized by the Ministry of Public Administration and Justice on October 12 where CESCI was involved as a co-organizer. The Memorial Day included an international miniconference and the presentation of the awards of the professional tender announced in the spring (jointly with Pálfi István Foundation for Regional Development).

 International conference on the role of professional organizations supporting cross-border cooperation

Supported by the National Civil Fund Programme, the Ministry of Public Administration and Justice and the France-Hungary Initiatives Association, CESCI organized an international conference on December 9 and 10 2010 where we signed a strategic co-operation agreement with three other similar national support organizations in the presence of House Speaker, dr. László Kövér. Budapest Platform will start its work as an independent professional initiative in 2011.

Although CESCI's membership did not grow significantly, Iosif Matula, Romanian EP member agreed to join our Governing Board adding to the number of countries involved in CESCI and improving our lobbying power.

We have built useful professional relations with the competent directorate general of the Committe of the Regions, with several Hungarian ministries, with the abovementioned national professional organizations with the French Institute in Budapest and with the France-Hungary Initiatives Association.

CESCI's involvement in the establishment process of CETC EGTC, our analysis delivered to the Committee of the Regions, the signing of the Budapest Declaration and our participation in international events have all contributed to CESCI's improved international recognition.

In summary, 2010 was the year of professional and diplomatic consolidation accompanied by severe financial instability. In 2011, CESCI is planning to continue its networking activities and to stabilize its financial position.
