# A brief report of the CESCI Balkans 2023 Activities

Prepared for the CESCI General Assembly Meeting 2024

The financial capacity of the organisation was still limited during this period, but it upheld its main activities and supported cross-border cooperation in the Balkans through the following activities:

## Study on "The concept of Pannon EGTC's expansion to the Western Balkans"

CESCI Balkans has been commissioned to develop the "Concept for the Pannon EGTC Western Balkans Expansion" The analysis answered the following questions:

- What are the benefits of expanding the Pannon EGTC to the Western Balkans?
- · Assessment of the regulatory environment for the involvement of institutionalised bodies
- Assessment of the regulatory environment
- A concept for the extension of the Pannon EGTC to the Western Balkans, with a preliminary outline of possible further directions for institutional development to strengthen the EGTC's role.

## Strategic partnership with the EGTCs in Greece

CESCI Balkans participated in the Sofia conference on The Future of Europe (The role of Cohesion Policies and European Territorial Cooperation) and was subsequently invited by the Greek Helicas EGTC to launch a long-term strategic partnership. The aim is to develop a common strategy between the two institutions, in cooperation with the EGTCs in Greece.

Concrete steps were agreed upon: identification of actors and their roles, joint assessment of the need and design of a roadmap, definition of strategic objectives, and development of the Helicas EGTC's strategic and operational plan.

A special joint meeting in Thessaloniki is also planned, with the signing of a framework cooperation agreement.

## Activities with the Council of Europe in the Serbian-Bulgarian border region continued

- Continuation of the strategic planning process: the activity packages have been further developed and updated in line with recent events and their requirements.
- Support for the implementation of the activities foreseen in the Activity Plan.
- Further harmonisation and ensuring synergistic implementation with the IPA SRB-BLG 2021-2027 CBC programme.
- Support in legislative perspectives: initiatives to support legislative perspectives foreseen in the legal roadmap will help strengthen the legal basis for cross-border cooperation.

## The concept of the Western Balkans Centre of the University of Pécs

On the request of the Foundation of the University of Pécs, CESCI Balkans developed the concept of the University of Pécs Western Balkans Centre with the assistance of leading experts from the University. The nearly 100-page expert study contains a number of analyses and evaluations:

- Assessment and analysis of the existing organisational, human, relational, research and training capacities of the University.
- Mapping available and accessible Hungarian national and local capacities and resources.
- An evaluation of the "Western Balkans Centre" function in terms of the value proposition of the University, from an international perspective and in terms of the potential third mission of the University.
- To present the needs at national level, from a foreign affairs-diplomatic, economic-development and national defence perspective.
- A detailed presentation of the role that the University can play in the EU integration process of the Western Balkans through the development of the Centre.



Within the framework of the study, concrete measures and decisions were formulated, which, if implemented, will enable the Centre to be established and its mission to be launched. The study was presented earlier this year at the conference "Hungary and the Western Balkans" at the Institute of Regional Studies of the Centre for Economic and Regional Studies of the Hungarian Academy of Sciences.

Of these, only the projects prepared for the Adrion programme have been evaluated so far, and of the three projects submitted, the ADRURAL project was selected for support. The project aims to empower rural communities by applying a variety of tested and innovative smart solutions and other innovation models to address key social and environmental rural challenges.

The three-year project, worth more than €1.7 million, will be implemented by 10 partners. CESCI Balkans has a budget of EUR 100,100.00 of this amount.
