

ANNUAL REPORT of the year 2023





History

URBI was established in 1997 (registered at the Ministry of interior affairs in 29 July 1997 under n. VVS/1-900/90-12845) and for several years organized seminars about local and regional development in Slovakia for elected and executive representatives of local and regional government in Slovakia.

In July 2015 the association was revived, the URBI was transformed into CESCI-Carpathia (Central European Service for Cross-border Initiatives), the statute was changed and new authorities were elected.

On August 7, 2015, the changed Statute was sent to the Ministry of the Interior, and on August 21, 2015, the Ministry of the SR sent a new registered Statute of the association under VVS / 1-900 / 90-12845-1.

On March 14, 2023, there were registered latest changes in the Statute, adopted at the assembly in 2022 on the Ministry of Interior Affairs SR under num. VVS/1-900/90-12845-2.

CESCI-Carpathia is a member of the cooperating partnership network CESCI. The lead partner is CESCI Budapest and the other partner is CESCI-Balkans Novi Sad.

Activities 2023

<u>Project "#ACCESS – Promotion of legal accessibility across Slovak-Hungarian</u> border ",

targeting cross-border legal and administrative obstacles and financed from INTERREG SKHU program 2021 -2027 started on 1 May 2023.

Summary of the project: The main aim is to systematically unfold the persisting legal and administrative obstacles hindering stronger integration and a higher level of cooperation across the Slovak-Hungarian border and to promote their elimination. The main two interventions of the project are obstacle monitoring and obstacle management. As a result of the project, the partners will eliminate legal obstacles and develop solutions including a legal obstacles database, obstacle projects, legal recommendations, and a sensitization campaign addressing the authorities.
