2.1 Proposal of an international consortium - with a Norwegian lead partner

Horizon-CL3-2022-DRS-01-01 on Enhanced citizen preparedness in the event of a disaster or crisis-related emergency, under the theme of Disaster-Resilient Society

The title of the call: Empowering Citizens and Communities to Prepare for and Respond to Disaster (acronym OMG)

Decision (30/03/2023): not successful, score achieved: 12.5

Lead partner: Faculty of Social Sciences, Nord University, Levanger, Norway

The primary role of the UPS-CESCI RG, together with the Romanian Academy of Sciences, would have been to present the conditions for disaster management in the Hungarian-Romanian border region (disaster events, existing institutions, organisations, governance mechanisms in cross-border disaster management, projects to date, potential future cooperation, participation and preparedness of citizens in disaster management) at case study level, and to coordinate the 3rd work package of the project (technological background study).

4.2. Border regions facing a poly-crisis in the 21st century. Resilience and future perspectives of cross-border relations 10-12 September 2023 Wroclaw-Opole

The presentation focused on the security policy aspects of the migration crisis in close connection with the phenomenon of b/ordering-borderism. In addition to the presentation of the research methodology, the audience was introduced to the changes in the narratives in the speeches of the Presidents of the European Commission and the changes in narratives and vocabulary in the EU countries based on the EU documents for the period 2015-2022. The results were illustrated by graphs produced using Speak AI (sentiment analysis) and MAXQDA (word cloud, interactive word tree, etc.) softwares.
